Mr. Fox reported that the Yacht Club had a meeting with MP Vecchio regarding the Yacht Club. MP Vecchio requested that the Yacht Club reach out to area partners regarding their needs and requests. Currently, the Yacht Club needs to do something about the breakwater even if they do not receive funding from the Federal or Provincial Government as use of the marina continues to expand.

Mr. Fox presented two requests:

- 2. That the Municipality take over obtaining the necessary permits and approvals (LTVCA, First Nations, the Department of Fisheries and Oceans, MNRF, etc.)

Councillor Rowe inquired if municipal staff are qualified to move ahead with the Act-i-Pass. The Parks and Recreation Superintendent reported that his staff are first aid certified and he is in the process of updating vulnerable sector screenings for both staff and volunteers.

Councillor Rowe reported that the West Elgin Community Centre Board of Management approved the public skating as part of the Act-i-Pass program. She also stated that she will be reporting to the Board that West Elgin will be offering public swimming and public skating as part of the Act-i-Pass program.

Mayor McPhail asked about the purchase of a Zamboni coil and spark plugs. The Parks and Recreation Superintendent reported that the invoice was incorrect as it was a tune-up and four spark plugs. Mr. Slater reported that the Recreation Department has purchased 21 tables and that the Recreation Department is recommending the purchase of the folding chair as displayed in Council Chambers. The Department plans on purchasing approximately 200 and a trolley to store the chairs for use at the Rodney Recreation Centre.
