6.1 Application to ReZone 24801 Pioneer Line

6.1.1 H. James, Planner - Zoning Report 24801 Pioneer Line

Planner read her report and all comments that were submitted. Planner is recommending deferring any action for one month until the current owner of the property and the properties of 24793 Pioneer Line and 24803 Pioneer Line are able to enter into the Mutual Drain Agreement to protect the legal outlets created as part of past severances, but never registered on title.

Deferred

That West Elgin Council hereby receives the report from Heather James regarding the application to amend the Zoning By-law for 24801 Pioneer Line, File No. D14 07-2020; and.

That West Elgin Council consider deferral of the by-law to amend the Zoning By-law until the current owner of the subject lands and the owners of 24793 Pioneer Line & 24803 Pioneer Line enter into a mutual agreement drain and have such agreement registered on title for both parties to provide a legal drainage outlet for 24793 Pioneer Line with a timeframe of one month for completion.

6.2 Public Comments

Amy Dale, Legal representative for potential purchaser of 24801 Pioneer Line. Ms. Dale stated that she believed many of the issues could be dealt with through Lower Thames Conservation Authority permits as well as Building Permit regulations. The issue of drainage has just recently come to light and therefore the purchaser is ok with the recommended deferral of a decision for one month at this time as they want to be good neighbours.

C. Blair, resident - Catherine Road, West Lorne - Ms. Blair stated that there is already a fair amount of drainage concerns with properties in this area and the property in question is where the majority of surface water runs. Ms. Blair is concerned that the existing drain is not large enough to handle more water.

6.3 Council Comments

Mayor McPhail stated that is seems that a drainage plan needs to be worked out for this area, which is separate from the issue of the missing mutual drain agreement. Mayor McPhail asked Drainage Superintendent Tom Mohan to speak with the concerned residents and see what can be done to alleviate concerns.

Tom Mohan, Drainage Superintendent responded to Mayor McPhail that a site meeting should be held with concerned property owners regarding the concerns on Catherine Street. There is a potential that if someone petitions the mutual drain that is currently servicing the two recently severed properties could become part of the Municipal Drain, but otherwise an agreement would need to entered into with each party and the current owner and then registered on title.

Council directed staff to pursue a mutual drain agreement with both lots on Pioneer line and the current owner of 24801 Pioneer Line in a timely fashion so that development can move ahead.

7. Delegations - 10 a.m.

7.1 Joe Machado and Christie Robinson - Utility Rate Increases for Multi Residential Properties

Mayor welcomed Mr. Machado and Ms. Robinson. Ms. Robinson thanked Council for the opportunity to bring forward their issues and the fact that the increased water and sewer rates cause a trickle down effect. Ms. Robinson went on to explain that with the rent freeze in effect due to COVID-19, they will be unable to recoup any of the increase through rent increases. She also stated that she would like West Elgin to implement a flat rate for multi-residential properties for the water and sewer.

Deputy Mayor Leatham inquired if there is a way that the building could be fitted with individual unit meters to allow for utility charges to be paid by the tenants. Ms. Robinson stated that could be done, but at a significant cost.

Council directed staff to report back to Council with comparisons with other area municipalities on how they charge multi-residential water and sewage charges and what the cost would be to the municipality if a flat rate system was implemented in West Elgin.

Council recessed at 10:54 a.m. and reconvened at 11:06 a.m.

7.2 Debbie Hope - Backyard Chickens

Mayor McPhail welcomed Ms. Hope. Ms. Hope thanked Council for allowing her to propose an alternative to the current ban on backyard chickens. Ms. Hope read her letter and provided information from other municipalities on backyard chickens.

Council stated that the pamphlet may have been overkill and they realize that many residents see chickens as their pets. Allowing backyard chickens would require amendments to the Zoning by-law, along with the Official Plan and the required public meetings could attract a large number which is just not feasible at this time with the pandemic, Council will consider this at a future meeting.
