Purpose:

The purpose of this Report is to provide Council with recommendations related to authorizing municipal comments to the County of Elgin regarding County of Elgin Consent Application E5-22, as Elgin County is the planning approval authority for consents.

The purpose of the application is to facilitate the residential lot creation within the hamlet of Eagle.

The Public Hearing is scheduled for February 23, 2022 at the Elgin County Land Division Committee Meeting.

Figure One below, depicts the existing parcel of the Ott Lands.



The severed and retained parcels for E5-22 are shown in a consent sketch, is attached to this report as Appendix One for reference purposes. There are abilities to further subdivide the proposed retained parcel into rural residential lots, should the Owner wish to proceed in the future, as Planning Staff has further detailed with the Owner of the lands.

Financial Implications:

None. Application fees were collected in accordance with the Municipality's Fees and Charges Bylaw, as amended time to time.

Policies/Legislation:

Planning authorities must have regard to matters of Provincial interest, the criteria of the *Planning Act*, be consistent with the Provincial Policy Statement (PPS) and does not conflict with Provincial Plans. Within the Municipality of West Elgin, they must also make decisions that conform to the County of Elgin Official Plan (CEOP) and Municipality of West Elgin Official Plan (OP) and make decisions that represent good land use planning.

With regard to this proposal involving severances, the Planning Authority is the County of Elgin Land Division Committee, wherein the Municipality provides agency comments to the County of Elgin as part of their decision-making process.

PPS:

Lot creation is permitted within the Settlement Areas in accordance with Section 1.1 of the PPS.

The proposal appears to be consistent with the PPS.

CEOP:

The subject lands are designated Tier II Settlement Areas on Schedule 'A' Land Use in the CEOP, wherein detailed land use designations are provided within the OP.

New lot creation policies of the CEOP contained under Section E1.2.3.1, has 13 criteria listed and would appear to be achieved with this proposal will be partially serviced, will not affect drainage patterns in the area, and entrance access to the lands can be obtained through Graham Road.

Therefore, this proposal appears to conform to the CEOP.

OP:

The subject lands are designated as Hamlet and Rural Residential, as shown on Rural Area Land

Use and Transportation Plan Schedule 'E' of the OP, as shown on Figure Two, with the orange colour being the Hamlet designation and the yellow colour being the Rural Residential designation. The proposed severed parcel would be in the Hamlet designation and the retailed parcel would be in the Rural Residential designation.

The Hamlet designation permits primarily single unit dwellings as well as some secondary uses of small-scale commercial, industrial, institutional and recreational uses and home occupations with limited servicing needs.



The Rural Residential designation permits primarily single unit dwellings on large lots and secondary uses of home occupations.

Lot creation polices under Section 10.4.1 of the OP, allows for severance (consent) applications to be the method utilized since no infrastructure is warranted with this proposed development and is in compliance with the criteria of Section 51(24) of the *Planning Act*.

Therefore, this proposal appears to conform to the OP.

Municipality of West Elgin Comprehensive Zoning By-law 2015-36 (ZBL):

The subject lands are zoned Hamlet (HR) and Rural Residential (RR) on Schedule E and Schedule

A, Map 70 of the ZBL, as depicted in Figure Three to the right.

The proposed new lot would within the Hamlet (HR) Zone at the southern portion of the subject lands. The HR Zone requires a minimum lot frontage of 25 metres and a minimum lot area of 1000 square metres. As the proposed severed parcel is 21.862 metres of frontage and 1,502.75 square metres, relief will be required for the



minimum lot frontage, as a condition of consent. The existing site location of the dwelling and garage on the severed parcel would comply to the zoning provisions.

The proposed retained parcel would be within the Rural Residential (RR) Zone and would comply with the zoning provisions.

Therefore, it would appear that the proposal would comply with the ZBL, subject to relief being obtained.

Interdepartmental Comments:

The consent application was circulated to municipal staff for comment, the following comments were received:

- Drainage Department
 - This property is assessed into 2 Municipal Drains Staddon and Mumford Drains.
 - The proposed severed parcel, according to information in the drainage reports, has its own roll number and was assessed separately for the Staddon Drain.

- For the Mumford Drain this property was re-apportioned in 1997 to create 2 lots to the north. In the same apportionment the proposed severed lot was also separately apportioned under its own Roll Number.
- Since the proposed new lot will be smaller than what the records show an adjustment may have to be made to balance the drainage assessment.
- Building Department
 - The applicants will require a septic inspection by the Building Department to view location and working order of the existing system. Please have the applicants contact the Chief Building Official to coordinate a site visit with their licensed sewage system installer when weather permits to view the system.

Planning Staff notes that this can addressed as a condition of consent by being re-apportioned and septic inspection and assessment being completed for the lands.

No other department comments were received.

All recommended lower-tier municipal conditions have been compiled within Appendix Two of this report.

Summary:

Therefore, it is Planning Staff's opinion that the proposed lot creation consent, would appear to be consistent with the PPS, conforms to the CEOP and conforms to the OP, complies with the ZBL (subject to relief); and that Council recommends to the County of Elgin that the consent be approved, subject to the lower-tier municipal conditions listed in this report.

The County of Elgin, as the Planning Approval Authority, will have to review the application accordingly against the planning documents (PPS, CEOP, OP and ZBL) and obtain comments from the other agencies and members of the public through the public consultation process, as part of their decision-making on the planning application.

Consent Application E5-22 Conditions:

- 1. That the Applicant meet all the requirements, financial and otherwise of the Municipality, to the satisfaction and clearance of the Municipality.
- 2. That the Applicant provides a description of the lands to be severed which can be registered in the Land Registry Office, to the satisfaction and clearance of the Municipality.
- 3. That the Applicant's Solicitor provides an undertaking to the Municipality, to provide a copy of the registered deed for the severed parcel once the transaction has occurred to the Municipality.
- 4. That the Applicant shall make payment of cash-in-lieu of applicable parkland dedication pursuant to Section 51.1 of the *Planning Act*, to the satisfaction and clearance of the Municipality.
- 5. That the Applicant successfully apply to the Municipality for a Minor Variance/Zoning By-law Amendment for the severed parcel and having such relief/rezoning of the Zoning By-law come into full force and effect pursuant to the Planning Act, to the satisfaction and clearance of the Municipality.
- 6. That the Applicant have a drainage reapportionment completed pursuant to the *Drainage Act*, to the satisfaction and clearance of the Municipality.
- 7. That the Applicant shall have a septic system assessment be completed by a qualified individual, on the proposed severed parcel to ensure that the existing privately owned and operated septic system is in working order and proper location and complete any improvements necessary, through a septic inspection, to the satisfaction and clearance of the Municipality.
- 8. That the Applicant shall have a septic system assessment be completed by a qualified individual, on the proposed retained parcel to ensure that the lands are suitable for a privately owned and operated septic system, to the satisfaction and clearance of the Municipality.
- 9. That the Applicant's Solicitor provide a request for clearance of conditions to the Municipality, demonstrating how all the conditions of consent has been fulfilled, to the satisfaction and clearance of the Municipality.
- 10. That prior the final approval of the County, the County is advised in writing by the Municipality how the above-noted conditions have been satisfied.
- 11. That all conditions noted above shall be fulfilled within two years of the Notice of Decision, so that the County of Elgin is authorized to issue the Certificate of Consent pursuant to Section 53(42) of the *Planning Act*.

The purpose of this report is to provide West Elgin Council with the Recreation Survey results and how the results will assist in the designing and redesigning of recreation programs for the community.

Background:

The West Elgin Recreation Committee directed staff in early November to put out a survey to assist in budget planning.

The Survey was made public on December 10, 2021, and closed January 01, 2022. 56 patrons participated in the survey. The attached PowerPoint provides details on the results of the survey and what activities and improvement can be done to increase recreation in West Elgin.

The West Elgin Recreation Committee viewed the Survey at the January 19th meeting. The Recreation Committee direct staff to revisit the survey at the February 16th meeting at which time the Committee and Staff will be creating a Work Plan that supports findings from the recreation survey including immediate, short and long terms goals for recreation in West Elgin. Once the Work Plan is established it will be reported to council for further information.

PURPOSE

Recreation starts at home and can be influenced on an individual or family basis. To encourage recreation in the community, we need to design programs that can encompass individual goals through sport or fitness levels as well as family goals.

Family goals may look different than individual goals, such as healthy eating, different socialization levels, or a place to make new friends. While individual goals could look like cooking for one, making new friends, and learning new skills to live alone.

- We need more nature areas with longer trails!
- Outdoor skating rink would improve community and get more people out as there wouldn't be such time constraints as the indoor arena. This would be a very important addition to Miller park that we would support.
- I feel safe with indoor with vaccine required.
- We need an indoor pool in this area for children and adult programs specifically swimming lessons for kids. To have to drive 35 minutes for kids to swim is crazy especially considering all the young families in this area!

- Once covid restrictions get reduced and life is back to "normal", I hope to see rec programs being promoted in the community. I feel there can be more advocacy done for \$\$, resources and support to build and expand services in West Elgin.
- The municipality should purchase the old WESES school, it could be used for so many programs and activities
- Being a fulltime working adult time and facilities are limited.
- Would like to have daytime pickle ball to free up courts for the people that work and can only play evenings.
- Thank you for all you do.
- Hoping for Rodney to have more activities or programs for school aged kids on weeknights (after school) and weekends. And to have more family programs and to have indoor swimming pool to be open all year round, rather than outdoor school that is only open during summer

- Provide opportunities within the community so kids don't have to leave. The indoor soccer program went over really well. Offering sports in
 our community will bring families and keep them shopping locally as well.
- Should install a disc golf course
- I would love to see a disc golf course at Miller park in West Lorne. It would be a great opportunity for the growing sport to get more attention. Since COVID, disc golf has been the fastest growing sport and there aren't enough courses. There is one in Windsor, one in Chatham, one in London and two in St. Thomas. Miller park is ideal because it could be used for the high school and elementary school students for gym class, encouraging youth to get outside more. I have experience with disc golf and running the league at the Chatham course. I would volunteer to run youth classes and grow the sport across the community. Furthermore, Miller park is underutilized. There are rarely people using the space, a disc golf course would bring more people, even from outside our community, bringing money to local businesses. I even have contacts that can design and build the course. Below is a list of further incentives/benefits disc golf brings to the community.

Background:

Purpose:

The purpose of this report is to provide Council with an update of operations carried out during the month of December 2021.

Background:

Utilities

- Locates continued for the next stage of fiber installation along Furnival Road between Rodney and Port Glasgow.
- Staff completed 4 water curb stop repairs during the month
- One utilities staff member completed snowplow training with the public works department. This operator holds a DZ licence and assists public works during the winter season, thus making good use of available resources.
- Roof repairs were completed above the West Lorne Library (flat roof). The contractor found a drain seal missing which had caused the water infiltration.
- All HVAC systems, including duct work, were professionally cleaned at the West Lorne Complex, Rodney Library and the Rodney Recreation Centre.
- Continued with regular maintenance, reads and utility requests
- Staff were able to coordinate some time off to use up remaining vacation time.

Public Works

- Sweeping of curb and gutters was completed by Mobil Sweep of London
- Dragging of gravel roads continued into December to keep them in good condition before freeze-up occurs
- Tree removal took place with the assistance of a contractor to handle areas where a bucket truck was required.
- Crews replaced a 1050mm diameter road culvert on Carroll Line between Graham and Dunborough
- Crews replaced cable guiderail on Marsh Line west of Furnival which was found to be damaged.

- Excavation was completed for hydro installation to the new electronic signs located in Rodney and West Lorne.
- Traffic control was provided for the Night Market held in downtown Rodney and the vaccine clinic held at the Elgin International Club.
- Training for snowplow operations and road patrol was provided to all applicable staff and taken jointly with operators from Dutton-Dunwich and Southwold to help reduce costs.
- The public works department winter shift began in December. This schedule has staff members on duty between 4am and 11pm (Mon-Fri) and road patrols competed twice daily (Sat-Sun) to monitor for adverse weather/road conditions.

Parks and Recreation

- Arena operations continued as normal during December with some extra bookings taking place over the Christmas holidays.
- Winter maintenance of sidewalks was completed multiple times during the month
- Rec staff assisted various local contractors to complete renovation work at the Scout Hall in West Lorne. Rec and Utility staff will be completing the project by painting trim and connecting plumbing fixtures in January.
- Assistance was provided to the Rodney Night Market Committee to coordinate efforts from the various municipal departments. I think all who attended this event would agree that it was a great success!
- All areas of the municipality were well represented in the holiday decorating contest with many great entries. A big thank you to all those who took the time to submit their address for the contest and the volunteers who travelled West Elgin for judging purposes.
- Programming at the Rodney Rec Centre started the month strong, with residents enjoying shuffleboard, pickleball, card playing and indoor walking. Unfortunately, these activities had to be suspended mid-month due to rising cases of COVID-19. Staff are continually monitoring the situation to determine when these programs can be started again.

Purpose:

The purpose of this report is to bring to Council's attention the TVDSB possible changes to their boards composition and to gain support for an initiative to ensure that the TVDSB composition continues to balance rural interest and urban interests.

Background:

Since it is an election year, the Thames Valley District School Board can make changes to the composition of their Board of Trustees. According to the calculations, Middlesex County is considered a low population municipality, and they do not meet the requirements for two (2)

Trustees. In the past, Middlesex County has been officially designated a low population municipality by the Board, and this designation has allowed them two (2) representatives on the Board.

Without this designation, Middlesex County would be allowed only one (1) Trustee on the Board. This would reduce the number of rural representatives from six (6) to five (5) and increase the number of representatives from the City of London to seven (7). This change would result in five (5) rural representatives and seven (7) urban representatives on the Board.

In 1998 the Thames Valley District School Board (TVDSB) was formed, through the amalgamation of the former Middlesex County Board of Education, Oxford County Board of Education, Elgin County Board of Education and the City of London Board of Education. Upon amalgamation the TVDSB Trustee distribution consisted of two (2) Trustees elected in each County (Middlesex, Elgin, and Oxford) for a total of six (6) Trustees, and six (6) Trustees elected in the City of London.

The TVDSB electoral group population has remained consistent since amalgamation, between 400,000 and 999,999. As such, the TVDSB qualifies for a total of twelve (12) Trustees for the TVDSB geography, and one (1) Indigenous Trustee appointed per Ontario Regulation 462/97. The number of elected Trustees and the distribution within a Board's jurisdiction is governed by Ontario Regulation 412/00, in which the Regulation (the Act) requires school boards to pass a resolution by March 31st of an election year, either designating one (1) or more municipalities as low population, or declaring that no such designation will be made.

The electoral quotient (2018) for Middlesex County meets the requirements for Middlesex County to be designated as a low population municipality. By Board resolution, Middlesex County has historically been designated low population, and has been allotted two (2) Trustee representatives. As contained within the Act, the Board must consider the following principles when making this designation:

- 1. Municipalities with low populations should receive reasonable representation.
- 2. Evidence of historic, traditional or geographic communities should be taken into account.
- 3. To the extent possible, the identification of low population municipalities should permit the establishment of geographic areas that coincide with school communities.
- 4. Representation should not deviate unduly from the principle of representation by population. O. Reg. 412/00, s. 4 (4).

At a recent Elgin County CAOs meeting this information was discussed and the County brought forward a similar report and request at its January 20, 2022 meeting and sent out the information to all lower tier Council's for their consideration. The County provided a sample letter (attached) for Council's consideration as well.

Attached please find our internal review, as we undertook to complete, of the noted initiative and the concerns/complaints identified during the West Elgin Council meeting December 2nd, 2021.

We trust that our review will provide insight to Council regarding this matter. PGYC did not, with this initiative, nor will we with any future project in partnership with the Municipality arbitrarily engage in any unsanctioned work. Our sole intent as a community service organization was to assist the Municipality in enhancing safety, usability, and appearance of Port Glasgow for our community.

Please be advised pursuant to our By-Laws the PGYC Executive going forward for a two-year term is President Rick McFadden, 1st Vice President Remi Begin, 2nd Vice President John Crowell, Secretary Steve Kerr, and Norm Miller Past President.

PGYC REMEDIATION INITIATIVE EAST OF SIXTEEN MILE CREEK PORT GLASGOW MUNICIPAL BEACH

JANUARY 2022 THE BOARD OF DIRECTORS PORT GLASGOW YACHT CLUB
1. INITIATIVE and SCOPE

The bush/forested areas of Port Glasgow Beach to the east of Sixteen Mile Creek adjacent to the marina had not been managed in many years if at all and as result were grossly overgrown. Proposed remediation of this area included clearing of overgrown brush and invasive species and subsequent replanting native species. This initiative was discussed at PGYC Director meetings and various work parties in 2020/2021 and Directors felt that it was a worthwhile initiative to undertake for the betterment of Port Glasgow and the community.

2. PLANNING/COMMUNICATION/CONSULTATION

The remediation initiative was discussed with West Elgin February 23rd, 2021, at a Board of Management Meeting and there was agreement the initiative had merit however contact with LTVCA needed to occur and necessary approvals would be required before it could proceed.

On site meetings at various times in 2021 were arranged with Lower Thames Valley Conservation Authority (LTVCA) and various others. Present at the onsite meeting April 2nd, 2021, was Ms. Valerie Towsley Watershed Resource Technician, Norm Miller, Rick McFadden of PGYC, Mr. Lee Gosnell Manager of Operations and Community Services and Ms. Magda Badura CAO.

On June 15th, 2021, Mr. Greg Van Every Environmental Project Coordinator attended the marina along with his staff to meet with Directors Norm Miller, Dennis Lee and Ron Fox and then to commence re-planting on yacht club land east hill. After completion of planting, it was understood Mr. Van Every went to contact Mr. Lee Gosnell who was working on the west side of the marina that day.

Other contacts were made with LTVCA Mr. Jason Homewood Watershed and Regulations, Deputy Mayor Richard Leatham Council Liaison with LTVCA. PGYC. On December 14th, 2021, Mr. Greg Van Every Environmental Project Coordinator met with Norm Miller and Rick McFadden to review work done and plan for next steps.

It was the stated position of LTVCA that; the initiative had merit and would be of considerable benefit to manage the forested areas to provide an appealing safe area for numerous recreational uses of this area. LTVCA indicated permitting was not required however attached the caveat that no work could be undertaken until the nesting season of various bird species was complete usually by the second week of June.

PGYC subsequently engaged the services of GWG Resource Management a local firm that provides expertise in forestry management, planning and planting to develop a plan for clearing of unmanaged overgrowth and invasive species.

On receipt the GWG report, copy attached as an Appendix and previously provided to West Elgin, acting on the recommendations therein PGYC contracted the services of a local contractor, Summit Tree Services. A site visit was arranged and an agreement to conduct the work at a time to be determined was entered. At the Board of Management meeting June 15th, 2021, attended by PGYC, West Elgin Councillors and CAO Magda Badura the initiative was discussed, and it was determined that work may be deferred until 2022 owing to the nesting concerns identified by LTVCA, the busy marina and beach summer season, ground/atmospheric conditions and subject to contractor availability.

At this meeting West Elgin CAO Magda Badura was identified as the PGYC point of contact with West Elgin and Director Rick McFadden (Chair PGYC Maintenance and Security Committee) as West Elgin's contact with PGYC for this and any other initiatives of mutual interest. Summit Tree Service was able to commence work November 12th, 2021. Director Rick McFadden contacted and advised West Elgin.

3. CONCERNS/COMPLAINTS

Regarding the written complaint along with digital images received by West Elgin and other verbal complaints alluded to but not disclosed it must be noted these were received while initiative was and is still a work in progress.

No issue is taken with an individual's personal perspective. However, an opinion voiced without benefit of accurate information is rendered subjective at best. Viewing the digital images alone might give the impression the work was not at all well done. Opinions expressed regarding the work done would have greater relevance after the project had been completed. Conversely, positive comments that have been received on social media and in person regarding the work done thus far suggest not everyone is dissatisfied.

The damage to the footbridge that is scheduled for replacement is acknowledged. Regardless of how or who caused the damage it was expeditiously repaired by a club member or members. It should also be noted that; the footbridge is continually subjected to unauthorized vehicular traffic either ATV or smaller four-wheel drive vehicles during the dark hours or off season. The day after the damage was repaired and re-grading of gravel leading to the bridge apron was completed by a club volunteer, there was evidence of vehicles "doing donuts" throwing the fresh gravel onto the bridge and then traversing it and then into the creek.

With respect to communication concerns alluded to, there is no question that to be effective communication must be accurate, timely, flowing both ways and almost always can be improved upon. Any suggestion there was no communication relative to the initiative is incorrect.

4. PROJECT COMPLETION

Mr. Greg Van Every LTVCA has completed a detailed plan, copy attached as an Appendix, for re-planting with various native species that will enhance both the health and appearance of the area east of the creek. Mr. Van Every was asked to provide an expert opinion regarding concerns with erosion and displacement of wildlife that has or may occur because of remediation along Sixteen Mile Creek. His response: erosion is not a concern, and wildlife will not be negatively impacted.

Re-Planting will be conducted in the spring 2022.

5. FISCAL IMPLICATIONS

There are no fiscal implications to the Municipality of West Elgin tax payors as the initiative was funded entirely by PGYC.

6. SUMMARY

Port Glasgow Yacht Club routinely conducts operational reviews of all projects undertaken focusing on; (1) were desired outcomes achieved, (2) what worked, what didn't work and (3) what could or should have been done differently. This remediation initiative that was undertaken by PGYC to support and assist the Municipality of west Elgin for the betterment of Port Glasgow is no different.

The project was not arbitrary in nature, extensive consultation prior to and during did occur. Expertise, advice, and permissions was sought out from the regulatory body and the private sector and that continues as the project moves to completion. Projects and initiatives undertaken by service organizations or municipalities for that matter, despite how well intended and implemented will never please everyone.

The common denominator in the area "what could or should have been done differently" is communication. This is not unique in any partnership nor is it an area that cannot be resolved by West Elgin and PGYC going forward. PGYC commits to work with West Elgin staff to develop a defined process that meets the needs of each.

Dear Norm & Duncan,

On February 16th, I met with Norm Miller to look at the possibility of rehabilitating the area between the beech & 16 Mile Creek at the Port Glasgow Marina & Yacht Club.

The following is what I observed during the walkabouts.

- Understory on the south side of 16 Mile Creek consists of many undesired shrubs (ie. Multi-Flora Rose, Wild Grape Vine, etc.) with patches of Phragmites (invasive specie) on the north side of 16 Mile Creek.
- There is some black walnut, white cedar, silver maple, tamarack, black locust, cottonwood & ash growing throughout.
- The one ash tree is dead & could become a hazard to the public.

My recommendations currently are:

- 1. On the south side of 16 Mile Creek clear undesired trees (black locust, ash, etc.) & shrubs (multi-flora rose & wild grape vines) to open up areas for picnic tables & viewing area of 16 Mile Creek.
- 2. Cut down the dead ash tree before tree becomes a hazard.
- 3. Retain all black walnut, white cedar, silver maple & any other trees that may be beneficial to the area.
- 4. Control the phragmites on the north side of 16 Mile Creek to stop it from spreading any farther along the creek.
- 5. After project is complete, possibly plant some native tree/shrub species throughout to provide diversity & habitat for wildlife.
