7.1 Carolyn Krahn, Manager of Economic Development, County of Elgin

Review of County Services and discussion of contribution and interactions with County projects.

Discussed the Master servicing study that Elgin County would like to complete in order to increase.

Identified Employment lands and how we can explore partnering with privately owned lands in order to service the lands to create future industrial lands to attract investment.

Work towards a clear vision, that supports West Elgin and Elgin.

Travis brought up a discussion around grants and how to make grants more readily available to West Elgin. Carolyn mentioned that they would be willing to travel with West Elgin and sit with small businesses in order to help business owners write grants or connect them with the resources in order for the businesses to apply for grants, as well as letters of support.

Travis proposed that the West Elgin EDC host a networking event for small business owners.

8.1 Elgin Tourism Signs

Carolyn brought some insight onto the county signs and stated that they were removing signs in order to streamline the signage in more populated areas.

There is an understanding that rural areas there is a different need for signage. She stated West Elgin can do our own signage program on local municipal roads. County roads would need county permissions. Robin to look into the policy around electronic signs and what can be advertised.
