**7. Staff Operations Update**

Installation of the dehumidification system is completed and has been running for 2 weeks now. sitting at 50% humidity, where it started at 90%. Additional guarding is needed around system outside for maintenance which will have to be looked into. There are funds remaining as the system came in cheaper than expected. Ice schedule is pretty much done for minor hockey and skating club. Ice contracts have started, and seasonal users have been reached out to. Minor hockey has increased their ice time this year, which has eliminated the Canucks time. Another set of hockey nets was asked for by minor hockey, but currently there is no room to store them. In the kitchen there is only the hood and fire suppression system, which we are asking Georgian Bay to decommission and could potentially sell. Compressors will be on September 2nd, and ice use will start the week of September 15th. With the hiring of the recreation coordinator, they will be helping with communications and the ice policy.
